 - d. Indigenous Inhabitant Certificate, ST Certificates & PRC should be signed only by District Administration not below the rank of Additional Deputy Commissioner.
 - e. All original documents are to be produced as when called for and also during the oral interview without which candidates will not be allowed to appear for the oral interview.
