**Qualification of Chairperson & Member, Child Welfare Committee (CWC):**

A Graduate and minimum Seven (7) years experience with Children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or Human development or in the field of law or a retired Judicial Officer.

**Qualification of Member, Juvenile Justice Board (JJB):**

A Graduate and minimum Seven (7) years experience with Children in the field of education, health, or welfare activities, or should be a practicing professional with a degree in child psychology or psychiatry or sociology or in the field of law.

**Age of Chairperson CWC, member CWC & JJB** : Above 35 years of Age & not more than 65 years

**Tenure Chairperson CWC, member CWC & JJB** : 3 years

**Honorarium** : Chairperson & Members CWC and of JJB shall be paid  
Rs.2000/- per sitting as prescribed in The Juvenile Justice Act.

**Terms & Conditions:**

1. Applicant must be a domicile of his/her respective district and his/her headquarter shall be maintained as the presence is required even at odd hours or on short notice and the appointment will be cancelled if headquarter is not maintained.
2. A person should not be associated with any organisation receiving foreign contribution.
3. Any person working in any organisation either NGO or organisation, performing such functions which may cause conflict of interest in discharging their duties.
4. He/she has no previous conviction record.
5. He/ she have not been involved in any immoral act or in the Act of Child Abuse or employment of Child Labour.
6. No enquiry is pending against him/her in any agency / court.
7. The applicant should not have any past record of violation of human rights or child rights.
8. The applicant should not have been removed or dismissed from the service of the Central or State Government or an undertaking or corporation owned or controlled by the Central or State Government.
9. Applicants for Chairperson and Member of Child Welfare Committee should file an affidavit as per Rule 15 (4A) Form 49 Juvenile Justice Act State Rules
10. The present Members of Juvenile Justice Boards (JJB) who are re-applying, the Appraisal Performance Report (APR) has to be endorsed by the District Judge of the concerned district.
